More work needs doing on the placing of these pieces of land on either side of Ratcliffe Street (formerly Dog Lane, Spicers Lane). The 1786 Plan (and the 1716 map) shows a large rectangular block of land at the rear of F29 extending to the rear of C75.

Until the end of the 18th c. the north Backway (Witherley Lane) gave access to the open fields from the rear of the burgages of the houses on the north of Long Street, east of the Brook between C74 and C75. The plots to the west from C75 to F29 at Dog Lane were shorter and a large croft obstructed their access to the Backway. To the west of Dog Lane one plot, F31, had access through to the Backway (known as the Kydde Gap, or Kip Kap Lane). This access may have been over the Tenter Croft which adjoined the Swan (F33) and extended to Dog Lane, (see 1724, L2/1, p.222) where the Croft is described as, 'as 'near adjoining le Swan Inn' ½ virgate, and 'adjoining Syiers Lane alias Dog Lane on one side and Witherley Lane on the other.' This entry also mentions that the Tenter Croft is described in other courts as '¼ burgage'. [This could suggest that ½ virgate and ¼ burgage had the same value]. (See F31, MR 9/6 1,[2], 173, below, for more information on the access to Backway of 'Yard Ends' as it was sometimes known)

At the end of the 18th c. Abraham Bracebridge, who lived in Atherstone Hall, succeeded in having the back road re-routed so that it no longer passed in front of the Hall. This necessitated moving the north Backway south so that it lined up with F33 File 018. The new road was laid through the narrow yard of the Swan and cut through or along the edge of the burgages of the houses which fronted Long Street (see WRO HR36 for records of the court case which preceded the diversion).

F28 and F29. 112 (Albert Hall) and 114 Long Street. This began as one burgage held by 'The gild' in 1547. It was rented to John Abelle. By 1587 it was split into two front properties and, as it appears, two rear properties. By 1660 the front plots of F28/29 had been reunited into one freehold property rented by Alice Abell and remained reunited until c.1786. The three separate pieces of bac kland abut each other and are clearly part of F28.

C95 and C96 were undoubtedly well positioned at the heart of the town and may well have had their burgage value increased to reflect that, although there was no increase in the actual size of the plot.
