F45-F54 Very little information on the early history of these plots has yet come to light. All properties were freehold and were in the possession of Merevale Abbey. A rental for 1497 lists 12 cottage tenants (TNA E315/283,f.8) some of whom may have rented these plots, but it is impossible to identify which (see introduction). After the Dissolution they were granted c.1540 by Henry VIII to Sir Walter Devereux (Lord Ferrers and Chartley). A bailiff's account exists for 1543-4 (BCA Ms 168242) but none can be definitively identified for these properties. F47- 49 (F48 with abuttals) can be identified from a grant of property made in 1649 by William, Marquess of Hertford etc. to a group of Warwickshire gentlemen of 13 freeholdings (Dugdale 1658, kept at Merevale Hall and available to be viewed by making a request to Warwickshire County Record Office).

Another theory about the early history of F45-F54 is that it remained as a close rented out by the Abbot of Merevale to John Hochynson (alias Nottingham). There are two conventual leases (leases for religious houses now dissolved) TNA E303/17. No 358, dated 19 March [1529]: William Abbot of Merevale to John Hochynson of Atherstone, mercer. Their closes called Newtown Close for 31 years. Rent 13s 4d. No 303, dated 8 August [1534] to John Hochynson of Atherstone, mercer, close called the Newtown close 31 years. Rent 13s. 4d. Slater has observed that these short plots were probably once one large plot which fronted onto the Market Place. (*Atherstone: A Pleasantly Placed Town*, p. 24.) The longer plots to the far west of Long Street (C113-C120 were likely to have been the last part of the town to be laid out. Perhaps F45-F54 remained as a rented close after C113-C120 were laid out. (C112 has been excluded as it was a short copyhold plot which must have been part of this close, but by 1547 appears to have had a dwelling on it – a ½ burgage in the tenure of John Edwards.) See also notes above before F39-44.
